#### Minnesota Chapter Surpasses 500 Members

**Minneapolis, March 12, 2008 - the Mississippi Headwaters Chapter** of the U.S. Green Building Council, located in Minnesota, announced today that its membership has surpassed 500 individual members since the Chapter began accepting memberships in June 2005.

Membership includes 226 full members, where the individuals' company is a national USGBC member; 212 associate members, where the individuals' company is not a member of the national organization; and 69 Emerging Green Builders, which includes students and young professionals. In 2007, Chapter membership increased by nearly 350 individuals.

"Our Chapter is privileged to have more than 500 members collaborating for better building practices in Minnesota," said Sheri Brezinka, President of the Mississippi Headwaters Chapter and Marketing Manager for Weis Builders, Inc.
